Description & Key Benefits

Suitable Surfaces / Materials

Dashboards, door panels, consoles, interior trims, rubber seals, vinyl surfaces (always spot-test).

Do Not Use On / Limitations

Do not use on pedals/steering wheel or high-touch areas where slip is a concern. Avoid hot surfaces. For exterior, limit to trims (not tires).

Interior plastics/rubber/vinyl		Prime applicator; spread thin; buff excess for uniform gloss

Directions for Use

Work on a cool, shaded interior. Vacuum/wipe dust. Apply a small amount to a foam or microfiber applicator (avoid overspray); spread a thin, even coat in straight, overlapping passes. After a short set time, buff off any excess with a clean edgeless microfiber. For softer sheen, dilute up to 1:3. Layer for more gloss; maintain with gentle interior cleaners.
