#### **Suitable Surfaces / Materials**

Avoid hot surfaces and direct sun. Do not saturate foam-backed materials. Keep chemical off leather/finished trim—wipe overspray promptly.

Light/Moderate soil	1:5	Mist panel; agitate; blot/extract; avoid over-wetting (esp. headliners)
Heavy soil / spotting	RTU — 1:0	Use undiluted; agitate, then blot or extract; allow to air dry

## **Directions for Use**

Vacuum thoroughly. Always spot-test in an inconspicuous area. Lightly mist GAME OVER, then agitate with a soft interior brush or microfiber in straight, overlapping passes. Blot and lift contamination with a clean edgeless microfiber. For heavier jobs, follow with a rinse/extraction pass and blot dry. Allow to air dry; re-vac to reset pile.
