Directions for Use

Work on a cool, shaded surface. Pre-soak a small panel with a fine mist of NEGATIVO. Wipe in straight lines using a clean, plush edgeless microfiber, flipping to a clean side as it loads. Final buff with a second dry microfiber for a streak-free gloss. Replace towels frequently.
